



TAX FORM 720

With many foreigners residing in Spain, the Spanish government decided to implement tax form 720 to fight tax evasion. If you are a resident in Spain, you are legally obliged to use form 720 to inform the government of all worldwide assets.

It is necessary for foreign residents to report to the Spanish Tax Administration about three different categories of assets and interests abroad:

- Foreign bank accounts
- Assets and investments abroad
- Properties you own or are responsible for abroad

WEALTH TAX - FILING THE FORMS

The wealth tax was reintroduced in Spain in 2011 after being abandoned for three years. The Spanish wealth tax applies to both residents and non-residents. For residents, it's for worldwide assets, but for non-residents it's only for Spanish assets.

For residents, if the net value of their worldwide assets exceeds 700.000€, with an extra allowance of up to 300.000€ of the property they live in, they are obligated to pay wealth tax in Spain.

For non-residents it's the same amount of 700.000€, but without the extra allowance for property. The deadline for submitting the wealth tax declaration is on the 30th of June every year.

Each region in Spain has the power to decide their own wealth tax regulations. These facts are obligated from the region of Andalucía, for example. Perez Legal Group has over 20 years of experience dealing with the wealth tax and can help you wherever you are in Spain.





NON-RESIDENT IMPUTED INCOME TAX

Paying non-resident personal income tax is common for foreigners in Spain, especially when they own or rent out a property. As a non-resident, you will have to make an annual declaration for income tax.

It is however only necessary to pay income tax for your financial activity in Spain, not for any income you have outside of the country. Non-residents will be taxed for the income they have earned in Spain and if you own a property, you will have to pay local property tax as well. If the property is owned by a married couple, it is necessary to file returns separately. Whatever your situation, contact us for advice on filing income tax.

FILING TAX RETURN FOR RESIDENTS

Most people in the majority of countries worldwide are required to file tax returns, this is also necessary in Spain if you are a tax resident.

To be a tax resident in Spain you need to spend more than 183 days here within a calendar year. You will also be considered a tax resident if you have a business in Spain or have your economic activities here, regardless of number of days spent in the country during the year.

The tax year runs from 1st of January to the 31st of December, and you will need to fill out a tax return in most cases, with very few exceptions. This usually needs to be completed between April and June each year.
